

• The ESLP label is a "Quality Label" created <u>exclusively</u> for specialties based on documented specific strains & associations and sold through pharmacies

• The ESLP Quality Label is assigned on spontaneous application

• The ESLP Quality Label is assigned after qualitative and quantitative microbiological analyses have been carried out by an independent laboratory (*Quality Partner SA*).




An **initial quantitative analysis** certifying that the specific strain (s) concerned are live and present in sufficient quantities (maximum 1 log difference from the amount stated on the packaging and in the instructions for the proprietary medicinal product). A second quantitative analysis conducted nine months later certifying that the specific strain (s) concerned are live and present in sufficient quantities (maximum 1 log difference from the amount stated on the packaging and in the instructions for the proprietary medicinal product).


Qualitative analysis with strain identification (DNA).




